FW-22 (Face Wrap - 22) is a geosynthetic reinforcement product for the face wrap of steep slope earth structures. Manufactured with polyester thread coated in PVC, the precision knitted geogrid provides a mesh structure for both erosion protection and space for vegetation to grow. The mesh is engineered to be both mechanically and chemically durable inert to biological degradation and resistant to naturally encountered soils. Imported.
